\$48 for the 1st \$1,000 + \$14 for each additional \$1,000 or fraction thereof

10,001-50,000

\$166 for the 1st \$10,000 + \$9 for each additional \$1,000 or fraction thereof

50,001-or more

\$514 for the 1st \$50,000 + \$6 for each additional \$1,000 or fraction thereof

EXAMPLE : If Project value is \$9460 then \$48 for first \$1000 leaving \$8460 which is more than \$8000; the fraction thereof is \$9000, so 9 (\$1000 fractions) x \$14.00 = a total of \$126.00 + \$48.00 = \$174.00
